

How does the DI production process work?

1. Fill in application form and state your expertise and timeframe
2. Receive invitation and information needed
3. Author:
 - write 10-15 pages (reimbursement for 40 h of work)
 - send draft to contact person of WP02 Task 2.2
 - receive reviewers' comments and revise document
4. Reviewer: assess 10-15 pages (reimbursement for 8 h of work)
5. Publication of final DI document (including DOI)
